

Proof of H3

This is just a one page list of all the proof being offered to confirm the substance behind the H3 operation. It's all linked.

1. **The FISCIL reform of the Global Fishing Industry** unambiguously adds between \$200 billion and \$300 billion to the global economy as it solves overfishing completely. It's also part of the approach to Climate Change.
2. **The Oasis reform of the Global Forest Industries** adds \$200 billion into the global economy as it solves deforestation completely. This is part of the approach to Climate Change also. This is what it adds up front. It adds more than this, but the extra \$2 trillion is added over about twenty years.
3. **The ANSR reform** can be found in the Climate Change discussion paper. It does most of the heavy lifting in the H3 approach to Climate Change, and it also adds a massive amount into the global economy. ANSR and FISCIL are the foundation of the H3 approach to Climate Change.
4. **The Water Tower technology** is zero emissions energy generation technology, and the details are all out in the open for any to view without patent protection. It's not that I'm giving it away, but there is a reason for it and it's explained in the last section of the Water Tower document.
5. **The Kyoto II reform** is a new global agreement to replace our current Climate Change agreement. It is designed to get all countries in the world moving in the same direction on Climate Change.
6. The **Eden is Burning** book is an introduction to the organisation that will make the H3 agenda happen, and inside a section called *Something to Think About* there are a half a dozen new technologies unveiled.
7. The **Save Steps** book is chock-full of substance, but as it is most of the H3 agenda broken down into one hundred bite-sized pieces, it's a bit of a long read to get to all the proof inside; unless of course you're looking to do one or more of the many deep dives available to you at this point.
8. There are four **other books** in the H3 literature currently available, and they all contain mountains of proof of substance.
9. And of course there is the **CNGE Initiative**.

Because most of the reforms listed here are too involved for you to be certain about, they can be viewed as proof of substance but not proof of value, BUT, the FISCIL Reform entry in the Climate Change discussion paper is simple and straightforward, and it is not possible, NOT POSSIBLE, for someone who has lived in this world to review that and then believe that we're not going to do it. The additional FISCIL stewardship details I included as an appendix in that discussion paper (and expand on in the FISCIL discussion paper) is something that can and will be debated, but the financial part of the FISCIL Reform is going to add over \$200 billion into the global economy (on day one), obviously so, and we ARE going to do it. So with FISCIL, the tech revelations in the Eden book, and so many other revelations in the books and discussion papers, it is not unreasonable for me to suggest that an old adage is applicable here: *where there's smoke, there's fire*. This operation is over twenty years in development, and it's going to be massive. Help me get it up on its feet.
